





# Mosque in Agios Ioannis/Ayyanni

### PROJECT OVERVIEW

Conservation works Start Date: March 2017

Conservation works End Date: September 2017

Type of proposed intervention: Conservation works

Total works cost: 82,000 Euro

The mosque is situated in the centre of the village of Agios Ioannis/Ayyanni, 43km east of Paphos. It is a rectangular shaped building and replaces a previous mosque. The mihrab is still preserved, as well as a simple wooden minbar.

The Mosque in Agios Ioannis/Ayanni forms part of the so-called "Paphos Cluster". Clusters are critical mass areas of monuments identified by the Technical Committee on Cultural Heritage in the Famagusta, Paphos and Karpasia/Karpaz regions, to promote the economic growth and territorial development of these areas, as well as to remedy to the maintenance problems emanating by the geographic dispersion of previous phases of the programme.

A 'Survey, Investigations, Assessment and Project Design' study was completed in June 2016.

Conservation works to the Mosque in Agios Ioannis/Ayyanni were fully funded by the European Union within the overall 14.7 million Euro Cultural Heritage Programme that the European Commission is implementing through UNDP in Cyprus.

The following major items of interventions were carried out:

- New retaining wall underneath the south façade.
- Grouting for the walls.
- The north wall to be rebuilt because of the inclination.
- Two anchor plates at the height of the brill for the stitching of the north and south walls.
- The gable on west façade properly reconstructed.
- Cement renders to be removed and to be plastered with compatible lime plaster.
- Where major and deep cracks exist "stone stitching made, as well as timber beams positioned.
- Existing doors and windows repaired and conserved; a new door in the women's gallery to be installed.
- The women's gallery to be rebuilt similar to the original ones and at the same position and height as the existing structure.
- Protective guardrails placed both in the entrance of the women's gallery.

- Railings between the road and the courtyard of the main entrance.
- Construction of an entrance.
- Rainwater arrangements in the courtyard.
- Additionally, floor marbles repaired and changed; internal plaster repaired and plastered if needed and mihrap painted.
- Roof checked and repaired.

Conservation works started in March 2017 and were completed in September 2017. The project was fully funded by the **European Union**. Total cost of works was approximately 82,000 Euro.

The Technical Committee on Cultural Heritage - The Technical Committee on Cultural Heritage, established by the decision of the two Leaders, works in line and within the mutually agreed framework for the preservation of the island's common heritage.
