#### Aim of the Brochure

The main aim of this brochure is to raise awareness to the public, regarding the need for the maintenance of the completed projects of the Technical Committee on Cultural Heritage, of our shared heritage. The brochure includes information regarding the possible pathology of the monuments which require maintenance, the tools for their short-term and long-term maintenance and the ways in which the public can contribute towards their preventive conservation. In general, this brochure aspires to involve more people in the effort of monitoring and safeguarding our monuments and our shared heritage.

#### Work of the Technical Committee on cultural heritage

In March 2008 the Greek Cypriot and Turkish Cypriot leaders established seven Technical Committees to work on confidencebuilding measures aimed not only at improving the everyday life of Cypriots, but also at encouraging and facilitating greater interaction between Greek Cypriots and Turkish Cypriots. The Agreement of 21 March 2008 reached between Greek Cypriots and Turkish Cypriots under the auspices of the United Nations (UN), paved the way for the establishment of the Technical Committee on Cultural Heritage (TCCH), dedicated to the identification, promotion and protection of the rich and diverse cultural heritage of Cyprus.


The TCCH is composed of an equal number of Greek Cypriot and Turkish Cypriot experts. The TCCH works to provide a mutually acceptable mechanism for the implementation of practical measures for the proper preservation, physical protection and restoration (including research, study and survey) of the immovable cultural heritage of Cyprus. The work of the TCCH is under the auspices of the UN and it constitutes an important tool for building confidence between the Turkish Cypriots and the Greek Cypriots. The TCCH is supported in its work by an Advisory Board (AB), which was established in 2009 and is composed of Greek Cypriot and Turkish Cypriot archaeologists, architects, engineers, historians and town planners.


In 2012, United Nations Development Programme (UNDP) initiated the implementation of the European Union (EU) funded activity Support to Cultural Heritage Monuments of Great Importance for Cyprus – Phase 1 and since then it has continued with the successful implementation of the EU funded activities Support to Cultural Heritage Monuments of Great Importance in Cyprus – Phases 2, 3, 4, 5, 6 and 7.

Since 2012, 102 cultural heritage sites island-wide are being or have been conserved, structurally supported, physically protected or restored by TCCH and UNDP, with funding from the EU. In addition, in 2019 UNDP initiated the European Union-funded project for the Support facility to the Technical Committees. The first output of this project constitutes the capacity building for cultural heritage management and maintenance. The creation of this brochure, to promote the maintenance of completed TCCH projects, has taken place within this framework. Meet Sofia and Ali. Two best friends from a small island called Cyprus. Sofia is a 25-year-old Greek Cypriot and Ali is a 27-year-old Turkish Cypriot and they both share a love for bike rides. This year they teamed up to make their dream come true! They will take a bike tour around Cyprus and discover the cultural heritage this beautiful island has to offer.

Hey Ali, did you get your gear? We'll need our bikes, some snacks and how about camping at night so we can enjoy the natural scenery?


Yes Sofia! I'm more than ready! I also prepared a map with all places we'll visit so we don't get lost. Let's go!


I saw a broom outside!





A: You're right! And also I can see some vegetation growing through the stones.


> S: But, let's continue now. I am really excited for our visit tomorrow at Zouhouri mosque in Larnaka.

#### Look Ali, what is this?



It seems that the local community is taking care of it! But look Ali, the gate is open. Shall we check if the lock is missing? This is a Turkish Cypriot cemetery, where TCCH implemented improvement works in 2020. It is still in good shape!

> Yes, let's check quickly! And then take the next bus to Limassol, before it gets dark.

A: This is one of the few hamams left standing in Cyprus and it is known as the Medieval Turkish Bath! It's great to see this as it is one of the most important ones, situated in the centre of the city of Paphos.

S: It's a very beautiful monument indeed! I read somewhere that it was part of a larger complex, built in the Medieval period. And during the Ottoman period it was modified and expanded. S: I can now understand the feeling of the hamam atmosphere. I wish we could use it as well, as they did in the past.

A: Sofia, look! Three of the glasses on the dome are missing.

S: This might cause damage to the building, especially when the rain season starts.

A: Yes! I know all about their work.

- P: Fantastic! So, it was great that you took initiative to clean the areas around the monuments, closed the doors and windows and also to thought about next steps, like organising clean-up events with your friends or people from the local community. Please tell me about the problems you spotted, which you didn't know how to deal with.
- A: Yes! We identified some broken windows, vegetation growth on several monuments, holes in the roofs and some missing tiles and stones.
- S: We also saw black stains on the walls, birds, and bird droppings inside the monuments.
- P: Exactly! These kinds of problems cause serious damage to the monuments over time and if people who visit spot and monitor them, then further damage can be prevented.

- A: This information is very useful! It's exactly what we were looking for.
- S: Thank you so much for this.
- P: Also, do not forget that visiting the monuments as well as monitoring, cleaning and other maintenance actions are secondary to your safety - You should always ensure your safety first!
- A: Good point! We will keep this in mind on our next visits and will not do anything that endangers our health and safety!
- P: We need more people like you, Sofia and Ali. We can safeguard our shared heritage for the next generations only if we all start taking care of our monuments.



An important monument in the history of Famagusta, Cyprus and the Mediterranean, the Othello Tower/Citadel was the first heritage site in Famagusta to benefit from the work of the TCCH.

The conservation project, which started in May 2014 was completed by July 2015.

Zouhouri mosque is a prominent historic building situated in the city center of Larnaca. The conservation project started in June 2021 and was completed in December 2021.



Lying on the east bank of the river, the watermill is located at the western edge of the village in the Paphos district.

The conservation project started in July 2015 and was completed by February 2016.




Located at the edge of a promontory overlooking the sea, near the tip of the Karpasia/Karpaz peninsula, in the northern part of Cyprus, Apostolos Andreas Monastery has always been a landmark of the island.

Works within Phase A of the overall restoration of the Apostolos Andreas Monastery, including the restoration of the church and the adjacent buildings started in September 2014 and were completed in November 2016.

The Paphos Hamam, was part of a larger complex built during the Medieval period and modified and expanded during the Ottoman period.

Conservation works to the Hamam started in June 2013 and were completed in March 2015.

> The Maronite Old St. George Church is located in the village of Kormakitis/ Koruçam. Built in the 16th Century, the church is adjacent to a nunnery. The Old St. George Church was the first Maronite heritage site to be preserved under the auspices of the TCCH.


Conservation works at the church started in July 2014 and were completed in July 2015.



The conservation works at Nicosia old city walls started in November 2019 and were completed in September 2020.

The project scope comprised emergency support measures in order to preserve the structure's current status and prevent collapse.







The TCCH has included improvement works at several Greek Cypriot and Turkish Cypriot cemeteries across the island to its projects.

## What can individuals do to protect monuments?

- Open windows and doors for humidity (\*ensuring that birds or pests will not enter and remain in the monument)
- 🖛 Clean the site from garbage and small vegetation
- 🖛 Clean the visitors' sign
- ► Water the plants
- ▶ Lubrication of hinges
- **r** Removal of insect nests, bird nests, cobwebs, etc.
- 🖛 General monitoring



## What to look out for when monitoring monuments?

- 🖛 Humidity
- 🖛 Blocked gutters
- 🖛 Cracks
- 🖛 Vandalism
- **w** Deterioration of metal and timber elements
- ▶ Vegetation on and/or around monument
- 🖛 Broken glass
- 🖛 Birds and pest infestation
- 🖛 Flooding or fire



Preventive Conservation encompasses, among others, monitoring of the monuments, which depends highly on the involvement of the community.
